At a minimum the analysis should be conducted whenever there are significant changes in airport infrastructure, operational practices, or patterns of demand.</p>	<p>1 August 2025</p>

This priority shall expire after the first season in which the significant change takes effect at an airport.</u>	Effective S27 Season
10.17.1	Priority during the transition related to significant WASG change	Coordinators must process all ad hoc slot requests from airlines and general/business aviation operators but should give priority to requests for series of slots. <u>Coordinators should give priority in the season significant WASG changes take effect at an airport to those ad hoc slot requests that operated in the previous equivalent season.</u> Generally, coordinators should not allocate slots for ad hoc operations before the Series Return Deadline.
