



## IATA ONLINE ACCREDITATION SYSTEM

### TERMS OF USE

---

The IATA Online Accreditation System (**Platform**) gives control and responsibility to Head Delegates (**HOD**) to add, remove and edit the details of their accredited delegates (**User**). It is each HOD's responsibility to keep their delegation's details up to date and remove them when they are no longer required to be accredited. The User access is governed by these Terms of Use, as well as IATA's Website Terms of Use available at: [www.iata.org/en/terms](http://www.iata.org/en/terms), and your use and registration shall be considered acceptance of these terms (including IATA's Privacy Policy available at: <https://www.iata.org/en/privacy>).

#### **Registration and use of your data**

IATA will process the information provided by the HOD to accredit their delegates to represent their organization at the IATA Slot Conference. IATA may also use the HOD's data to inform them of relevant information such as news and updates regarding slot advocacy, Notices of Airport Level Charges, updates to the Worldwide Airport Slot Guidelines, newsletters, and any other marketing information that IATA may deem beneficial and useful for HOD to receive.

#### **User's restrictions**

The IATA Online Accreditation System features a digital space for User to access relevant information about slots coordination processes, and it is restricted to Users authorized by IATA. Users must at all times:

- keep login credentials confidential and only use them individually;
- take all necessary and reasonable measures to protect and secure login credentials from unauthorized access;
- accredit only those individuals employed by the organization for which they are designated by the HOD (unless otherwise agreed in writing by IATA); and
- maintain confidentiality of the information and materials available on IATA Online Accreditation System (including any information available in its database).
