PAC3 (Mail A693)
Proposal to change the period from the end of sales period until the remittance date in Chinese Taipei

Submitted by APJC Chinese Taipei

Background Information

It is proposed to adjust the period from the end of sales period until the remittance date to ensure that it complies with the Resolution provisions. Currently, in the Chinese Taipei market this period is 8 calendar days. However, according to Resolution 812, Paragraph 6.5.3.6, the remittance date should be the fifth working day following the reporting date.

The APJC Chinese Taipei convened on the 4th of November 2024. All APJC representatives present unanimously agreed on the plan to adjust the period from the end of sales period until the remittance date from 8 calendar days to 5 working days, starting from 20250901W, the first BSP sales period in September 2025 (1 September 2025 to 7 September 2025). The meeting was attended by 7 airline representatives and 6 travel agent representatives, while 1 airline representative and 2 travel agent representatives were absent.

Effective Date

The proposed effective date of these changes is 1 September 2025 (Billing period 20250901W).

Proposed Action

Conference to adopt the changes to the remittance period as shown in Attachment 'A'.

The timetable for this Mail Vote is as follows:

Voting Period: 20 January-3 February 2025

Filing Period: 4-18 February 2025

Effectiveness: 1 September 2025 (Billing period 20250901W)
