**UPDATE OF THE ATTACHMENT 'I' OF THE RESOLUTION 812** 

### **Background Information**

After a thorough review of Attachment 'I' of Resolution 812, it was noted that the Daily Remittance frequency for the United Kingdom was not included, and the country Liechtenstein was omitted.

IATA would like to request the inclusion of both updates in Attachment 'I' of Resolution 812.

Additionally, it is proposed to amend the End of Sales Period to Remittance date for New Caledonia, replacing current 16 days with 8 days.

#### **Effective Date**

The proposed effective date of these amendments is 1 January 2025.

#### **Proposed Action**

Conference to adopt the amendments to Attachment 'I' of Resolution 812 as shown in the Attachment 'A'.
